For all candidates, the knowledge of computer is desirable and shall have to pass the CCC+ examination within 6 month of joining as per regulation of GMERS, for those only who have not passed earlier.

Those candidates in-service elsewhere have to submit relieving order from their employer at the time of appointment or affidavit on Rs.300 Stamp stating that he/she has served in that college and resigned after paying notice pay or notice period along & payment proof.

The candidate who passed DNB examination from private Hospital are required to submit the certificate that hospital has 500 Beds.

In the subject of Anatomy / Physiology and Biochemistry, M.Sc., Ph.D. candidate are also eligible as per NMC Norms. **BUT IF MD/MS CANDIDATES WILL BE AVAILABLE, THEY WILL BE GIVEN PREFERENCE AS PER NMC RULES.**

The contractual appointment will be for 12 months contract which can be renewed as per appraisal by competent authority.
