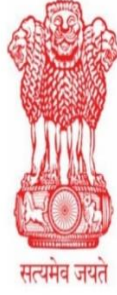

CORRIGENDUM

Subject: Modifications to Application Process for Advertisement No. 02 of 2025-reg.

Reference: Advertisement No. 02 of 2025, dated April 05, 2025

It has come to our attention that several candidates have only submitted their applications via the Google Form link provided in the above-referenced advertisement and have not emailed the required scanned copies of documents along with the filled offline application form, primarily due to technical issues related to PDF file size limitations.

In view of these challenges, the following modifications have been made to **Clause I (How to Apply)** of the original advertisement:

- 1. Online Application Submission:** All candidates must submit their applications online using the Google Form link provided in the original advertisement by **April 12, 2025**.
- 2. Mandatory Google Form Submission:** Candidates who fail to submit the online Google Form by **April 12, 2025**, will **NOT** be permitted to appear before the Document Verification Committee.
- 3. Document Verification and Interview:** Only candidates whose documents are successfully verified by the Document Verification Committee will be allowed to appear before the Interview Board.
- 4. Compliance Requirement:** No exceptions will be made for candidates who fail to submit the online Google Form by the specified deadline.

All other clauses of the original advertisement remain unchanged. Candidates are advised to ensure compliance with the revised instructions to avoid disqualification. All applicants must visit the website (www.esic.gov.in) regularly since all subsequent Corrigendum/ Addendum/Updates will only be uploaded to the website.
