Sub: Time-extension to under-implementation solar PV/ solar PV-wind hybrid power projects wherein last date of bid submission was prior to 09.03.2021 – reg.

Madam / Sir,

It was announced on 9<sup>th</sup> March, 2021 that from 1<sup>st</sup> April, 2022 any import of solar PV modules would attract Basic Customs Duty (BCD) of 40% and import of solar PV cells would attract BCD of 25%. There are several projects for which bids were finalized by agencies of the Government (SECI/ NTPC / NHPC) before the said announcement. Normally, these projects would have been completed before the imposition of customs duty; however, because of COVID and the resultant supply chain disruption, these projects could not be completed before the customs duty took effect. While a decision on bids which were finalized before the announcement of customs duty is pending, in the mean-time, the extended completion dates of many projects have expired.

- 2. It has therefore been decided that solar PV / solar PV wind hybrid projects, for which bids were finalized before 9<sup>th</sup> March, 2021 (i.e. the last date of bid submission was prior to 9<sup>th</sup> March, 2021), may be given time for completion of projects upto March, 2024.
- 3. This issues with the approval of Hon'ble Minister (Power and New & Renewable Energy).
